flag pole, etc. A motion was made, seconded and passed to form a committee consisting  
of PDC Stefany, JVC Marc Finnegan, DC Terry Dyer and Eagle Scout Officer Tom  
Oestreicher.

Hecker Camp #443 JVC Garry Ladd spoke on the subject of film maker Ken Burns will  
be hosting a talk at S. Ill. University about the 150<sup>th</sup> anniversary of the Civil War as well
